The application will be submitted to the Nominations Committee to review and confirm is a Member of Tourism Barrie and in good standing.

The Nomination Committee will then interview the candidates to determine whether they would be suitable to become directors of the Corporation, particularly in light of the Corporation's mission statement and objectives.

The Nomination Committee will provide the required written endorsement of the candidates from the Industry class, as detailed in the Bylaws, which will be presented to the Membership during the Annual General Meeting.

The Nominations Committee will present the list of candidates they recommend as the preferred candidates to fill the vacancy (s) on the Board of Directors. The names of those candidates and any pertinent information about them will be distributed with the final notice for the Annual General Meeting. The Board of Directors shall be elected by a majority (50% +1) of the voting members at the Annual General Meeting,

Candidates not recommended by the Nomination Committee can stand for election on the day of the Annual General Meeting. As set out in the bylaws, they must have the written endorsement of two members of the Industry class who are in good standing and the candidate must be in good standing as a member of Tourism Barrie. Candidates announce their intention to stand for election when Nominations are called from the floor.

The Directors shall hold office for a four-year term for a maximum of two terms or until successors are elected or appointed.

A majority of the votes cast by the Members who are entitled to vote shall determine the questions in the meeting except where the Act or By-laws require the vote or consent of a greater number of members.

- **Statement of Endorsement:** Clearly state that you are endorsing the nominee.
- **Nominee's Qualifications:** Highlight the nominee's relevant experience, skills, leadership qualities, and contributions.
- **Alignment with Organizational Goals:** Explain how the nominee's expertise aligns with the board's objectives and strategic direction.
- **Personal or Professional Relationship:** Mention your connection to the nominee and why you believe they are well-suited for the role.
